



Performance Contract

Yasmeen Amina Olya

Professional capacity as both a musician and composer.

Yasmeen Amina Olya is an independent musician, she acts independent of agent and or record label. Yasmeen Amina Olya reserves all rights of her musical compositions, written, recorded and performed.

To hire YAO, you must agree to the criteria in this document and sign an agreement contract with the artist.

Definition of Performance Agreed to by the Artist.

YAO, the artist is willing to work under contract in the capacity of musician and composer :

For concerts. The artist agrees to perform in churches or auditoriums, and other venues where there is no alcohol sold or consumed. Where there is either appropriate ambience and echoes for her natural performance or where the sound system implemented is appropriate for her performance.

There must be a private entrance and exit to and from the stage for the artist inside the venue.

If the artist is required to re-locate for a performance, all costs for travel, lodging and living must be paid in full before the period of hiring is engaged, and a contract agreed upon.

YAO, reserves the right to cancel performance in the event of a physical injury, medical emergency or sickness, preventing her ability to perform. YAO reserves the right to all funds, during her re-location, in the event of physical injury, medical emergency or sickness, allotted for her travel lodging and living expenses, during the period of hiring.

For music recordings. If you wish to hire or use the services of the artist, in a vocal capacity and or as a harpist for a CD you are recording or for other materials, such as video or sound track.

The artist must be able to review, all material before accepting contract. (listen to samples, read physical music, understand completely what is required)

The artist in the capacity of vocalist and harpist, reserves a period of 3 months, to rehearse proposed parts, for an album of 30 minutes in length, to be agreed on during a time when the artist is free from other commitments. For albums where just vocals or just harp is required, 1-2 month may be enough, the artist reserves the right to ascertain the appropriate period of time for rehearsal.

The artist must be given easy access to the recording studio, and enough time to be satisfied with the outcome of the recording.

When acting as a recording artist, not as a performance artist. YAO, agrees to work long-distance via internet and in a local recording studio.

The artist reserves the right to choose the appropriate recording studio for recording her music at her best capacity.

The artist reserves the right to refuse publishing of her part if, after the recording, or mixing, or editing, the outcome is not satisfactory.

If it is required that the artist re-locate for recording. All travel, lodging and living costs must be paid in full by the client hiring the artist, and an agreement signed.

Date, time, compensation, and signature by both parties must be created and agreed upon.

Definition of performance.

Both parties should know what is expected for a "performance." Provide a clear yet concise description of the nature of the performance, including minimum length, set breaks, and anything else unique to the performance.

Location, date and time. This must be confirmed and re-confirmed, in writing. specific period of time for performance can be included.

Compensation. It should be clear whether a fixed amount (guarantee), a percent of door or revenue, or both. Include when payment will be made, to who, how, and any deposits. YAO is the sole payee for her services. If payment is based on percent of door, both parties should have the right to be present in the box office and access to box office records or gross receipts.

Recording, reproduction, transmission, photography. This is the artist's right to grant specific permission. Use of Performer's name and likeness in advertisements and promotion can be used after the artist has agreed.

Right to sell merchandise on premises. terms must be agreed upon.

Meals, transportation, lodging. Must be provided, and agreed upon by the artist, in the event of re-location

Sound and production. It should be clarified and agreed upon who provides sound and how.

Permits, licenses, and taxes. To be covered by the Buyer.

In the event of unexpected illness, emergency, physical injury. The artist reserves all rights to cancel performance.

Cancellation. To be agreed upon

Royalties and licensing. Yasmeen Amina Olya reserves all rights to her music.

Insurance & Security. Personal liability insurance and property insurance are the responsibility of the Buyer.
